Highlights

Islamic veils, turbans, and specific diets require guidance from authorities; schools are left to "adapt" to cultural differences as best they can.

As the number of migrant students increases, public schools are facing practical challenges, such as deciding whether to allow specific clothing and what types of food to provide. However, some emphasise that welcoming foreigners into Portugal's education system goes beyond merely respecting cultural differences, and there is still much work to be done.

Since the 2020/2021 school year, the number of migrant students in Portuguese public schools has increased by 71%, now accounting for nearly 13% of the total student population. This rise reflects the arrival of students from various nationalities, particularly from Asian countries such as Nepal, Pakistan, and Bangladesh. While this diversity enriches the educational experience, it also presents challenges related to reception and adaptation.

CLOTHES - Yasmin couldn't go swimming because she wasn't allowed to wear a swimsuit. She even attempted to swim once in an outfit that covered her entire body, but they refused her entry to the pool because normal clothing wasn't permitted. In gymnastics, she wore pants and a tunic on top, along with a hijab. Once, she even tried taking off the hijab because it was uncomfortable, but she didn't want her mother to find out.

OTHER EXAMPLES FROM EUROPE

- About a year ago, France banned the wearing of the abaya, which is the Islamic robe that covers the entire body except for the face, in schools.
- In 2019, the Austrian parliament passed a law prohibiting Muslim girls aged 6 to 10 from wearing the veil in schools.
- These actions have led to complaints of discrimination, backlash from the affected communities, and lawsuits in international courts claiming that the measures are discriminatory.
- "It's a journey filled with both advances and setbacks. It's a learning process on both sides that takes place over time."
